**WHEREAS, the following are the lowest responsible and responsive bidders for the several areas of work in compliance with the bid specifications in connection with such Projects as recommended by Joseph B. Rettig, AIA, LEED AP, Architect, from Burton, Behrendt Smith;**

**THEREFORE, BE IT RESOLVED that the Board hereby awards the bids for the several contracts in connection with the Bond Referendum Projects - Phase 1, set forth above, as the lowest responsive and responsible bidders in compliance with the bid specifications, such awards as follows:**
